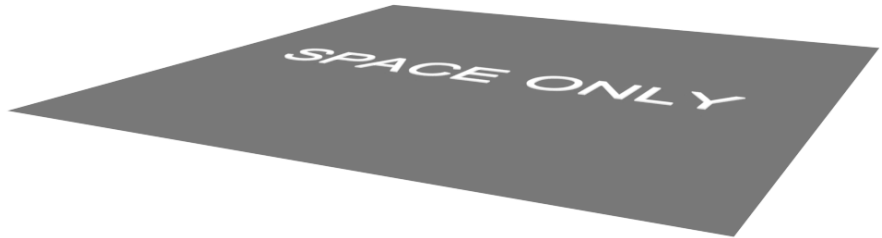

SPACE ONLY SPECIFICATION SHEET



WALLING

No walling is provided. Apart from an island stand, all exhibitors must build walls at least 2.5mH. The maximum build height is 5m.

FLOORING

No flooring is provided. You must provide suitable flooring for your stand. Flooring can be ordered through ExpoNet, or your appointed stand build. Refer to Exhibitor Manual for further details.

FRONTAGE

All stands must have at least one third of each frontage open or fitted with transparent material.

LIGHTING

No lighting is provided. Lighting can be ordered through ExpoNet at esd@exponet.com.au. Please refer to your Online Exhibitor Manual for further details. All items must be tested and tagged. This service is bookable through Exponet.

POWER

No power is provided. Power can be ordered through ExpoNet at esd@exponet.com.au. Please refer to your online exhibitor manual for further details. All items must be tested and tagged. This service is bookable through Exponet.

ADDITIONS

Additional items for your space may be ordered directly from ExpoNet, or from any of the official suppliers listed within the Online Exhibitor Manual.

STAND PLANS

All Space Only stands are required to submit a stand design to the organiser at least 45 days prior to the event for approval. The organiser reserves the right to reject any design if it does not comply with OH&S guidelines or venue building regulations. Please refer to your Online Exhibitor Manual for further details.

Ensure you have submitted these designs via the Online Exhibitor Manual, noting the due date.

SPACE ONLY REGULATIONS

By contracting a space only stand, Exhibitors agree to the following:

- We understand that this stand does not come with lighting, power, walls or carpet
- We understand we need to build our own walls, minimum height of 2.5m high.
- A 5-metre height limit applies to ALL stand designs. No exceptions
- The structure of our stand and contents sits within the contracted space
- Our adjoining walls are devoid of any branding overlooking neighbouring stands, and anything higher than 2.5m is finished (e.g. no exposed wood).
- Our stand has adequate pits for water/waste OR we do not require pits for water/waste
- All open sides are at least 1/3 open or have been fitted with a transparent material
- All double storey stands require engineer certification and engineer sign off when the stand is built prior to occupancy of the stand.
- A stand with a roof or ceiling is required to accommodate additional fire protection equipment, including smoke detector and fire extinguisher
- Stands deemed to have significant ceilings may require a Fire Engineer signoff as nominated by the venue at the exhibitors expense
- All material must comply with the Fire Hazard properties standards and codes and a Material Safety Data Sheet (MSDS) must be produced upon request
- Any flooring, steps and ramps included in the stand design comply with National Construction Code (NCC) standards
- Any custom-built stand with a floor area of more than 50m² is to be provided with at least one alternative means of egress to the walkways.
- Any barriers incorporated into the custom-built stand are to be designed so that they yield to pressure without toppling.
- Halogen lights are not permitted
- We are obliged to ensure all electrical items that come on site are tested and tagged, including those of our stand builder.
- Our designs include exact dimensions, aerial & plan views including height, floor height & ramping gradient
- Raised floor 33mm to 115mm high must have a clearly distinguishable ramp / beveled edge installed and incorporated into stand space
- Flooring higher than 115mm is deemed a step. If the stand is to be occupied by the public or exhibition attendees, a ramp must be provided within the allocated space.
- Rigging of any overhead structure or signage must remain within the perimeter of the stand space. Banners must be single sided when rigged on the perimeter of the stand that adjoins another stand otherwise the banner must be stepped in by 1m.
